

## IPH HOCKEY Participant Waiver and Release

In consideration of being allowed to participate in IPH Hockey events and activities, related events and activities, and in any way being associated with IPH Hockey (collectively, "the Program"), I \_\_\_\_\_, the undersigned, acknowledge, appreciate, and agree that:

1. I have taken the temperature of any person attending the Program with me or on my behalf, including my own and/or my child's, no more than two hours before arriving at any Program facility, and it is less than 99.0 degrees Fahrenheit; and
2. I have read, understand and agree to obey by all the guidelines displayed by the rinks and/or other facilities used by the Program, including any and all IPH Hockey's on ice protocols or other guidance; and
3. The risk of injury from participation in the Program is significant, including the potential for permanent paralysis and death. While particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injuries does exist. In addition, participation in the Program includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the serious illness and death does exist; and
4. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF IPH Hockey or others, and assume full responsibility for my participation; and,
5. I willingly agree to comply with the stated and customary terms and conditions for participation regarding protection against infectious diseases. I expressly agree that if I observe any unusual or significant hazard of any kind during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
6. **I agree to wear a mask at all times while in the facility; including on the ice; and**
7. **I have/am acting in accordance with all state and local requirements including but not limited to: travel restrictions, testing, and quarantine guidance enacted by the State of Connecticut; and**
8. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, AND HOLD HARMLESS IPH Hockey, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any events or activities ("RELEASEES"), FROM ANY AND ALL LIABILITY WHATSOEVER RESULTING FROM ILLNESS, DISABILITY, DEATH, or loss of damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

**I HAVE READ THIS WAIVER AND RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
